Work Activity Inconsistencies Data Dictionary

The spreadsheet identifies adults that appear to have more than 60 hours of activity in any federal work activity or more than 55 hours per week based on activity start and end dates.

Activity Number: The report lists columns with numbers in their titles - **act#err**, **act#**, **act#hrs**, **act#strt**, and **act#end**. The number (#) in each of these column titles simply refers to the placement of the activity on the report. For instance, act1, act1hrs, act1strt, and act1end combine to report the activity code, monthly hours of participation, start date, and end date for the <u>first</u> activity that appears on the report. Since an individual may have multiple activities in a month, they may have multiple columns of data on the report. The report allows for nine (9) work activities and sorts them in the alphabetical order of the work activity code.

- **1. jasoff:** JAS office number to which the individual is assigned.
- **2. jasunit:** JAS unit number to which the individual is assigned.
- **3. jascsld:** JAS caseload number to which the individual is assigned.
- **4. eiscsnum:** The EIS TA case number assigned to this family.
- **5. clientid:** Number assigned to any client registered to EIS or CMS.
- **6. Appdate:** The most current benefit start date.
- **7. fedhrsover:** Identifies adults with 60 or more hours per week in any one federal work activity. This combines the hours of the DPA work activities into the federally defined categories. The federal work activities are: unsubsidized employment, subsidized employment, work experience, OJT, job search, community service, vocational training, and high school or GED. An error is identified if the total in any federally defined category is over 60 hours.
- **8. act1err:** Activity 1 computes to more than 55 hours per week if there is a one in the column.
- **9.** act2err: Activity 2 computes to more than 55 hours per week if there is a one in the column.
- **10.** act3err: Activity 3 computes to more than 55 hours per week if there is a one in the column.
- 11. act4err: Activity 4 computes to more than 55 hours per week if there is a one in the column.
- 12. act5err: Activity 5 computes to more than 55 hours per week if there is a one in the column.
- **13. act6err:** Activity 6 computes to more than 55 hours per week if there is a one in the column.
- **14.** act7err: Activity 7 computes to more than 55 hours per week if there is a one in the column.
- **15.** act8err: Activity 8 computes to more than 55 hours per week if there is a one in the column.
- **16. act9err:** Activity 9 computes to more than 55 hours per week if there is a one in the column.
- 17. act1 (Work Activity 1): The code for the 1st work activity listed on the report (sorted alphabetically).
- **18. act1hrs (Activity 1 Actual Hours):** The number of hours participating in the Work Activity 1.
- 19. act1strt (Activity 1 Start Date): Work Activity 1 start date.
- **20.** act1end (Activity 1 End Date): Work Activity 1 end date or 99999999 if the activity has not ended.

Note: The report repeats items 17-20 to account for up to 9 activities
